WHAT YOUR NOTIFICATION MUST INCLUDE:

To be effective, the notification must include the following:

- 1. Your name, physical address, telephone number, facsimile number, e-mail address and name of contact person;
- 2. Identification of the copyrighted work(s) claimed to have been infringed;
- 3. Identification of the material that is claimed to be infringing or to be the subject of infringing activity and that is to be removed or access to which is to be disabled, and information reasonably sufficient to permit us to locate the material;
- 4. A statement that you have a good faith belief that use of the material in the manner complained of is not authorized by the copyright owner, its agent, or under applicable law;

- 2. Asymmetric Health shall inform the complaining party that it will replace the removed material or cease disabling access to it within ten (10) business days; and
- 3. Asymmetric Health shall replace the removed material or cease disabling access to the material within ten (10) to fourteen (14) business days following receipt of the counter notification, provided that Asymmetric Health's Designated Agent has not received notice from the complaining party that an action has been filed seeking a court order to restrain the alleged infringer form engaging in infringing activity relating to the material on Asymmetric Health's network or system.
